
Fussa Waste Rules Reduce and Separate Waste

This handout is for the people residing CENTRAL AREA in Fussa-city



Waste DISPOSAL is becoming a serious issue all over Japan. The city of Fussa is facing to this problem and must work rigorously to reduce and separate waste. There is only one landfill in western Tokyo, located in the town of Hinode. Fussa-city and most other cities in Tokyo are utilizing that landfill to dispose of cinders produced after burning waste.

Fussa must strengthen their waste policy and require all citizens to properly separate their waste into Eight categories and to use the designated collection bags for disposing of all Combustible and Incombustible Waste. Several kinds of waste bags are currently available for purchase in Fussa.

There are four areas in Fussa: Central, East, West, and South. Each has its own Calendar for waste Recycling with pick-up dates for the different types of waste. You will be provided with the appropriate schedule or your area.

1. Designated collection bags

You are required to use designated collection bags for "Combustible Waste" and "Incombustible Waste". It can be purchased at convenience stores and supermarkets in Fussa.

	Combustible Waste (collection frequency: twice a week) Kitchen waste, paper except for recyclables, food wrappers, leather, rubber, and other combustibles. Not to exceed 20 inches (50cm) in length.		Put them into designated collection bags for "Combustible Waste".
	Incombustible Waste, Small Household Appliances (collection frequency: every four week) Glass, crockery, light bulbs(not fluorescent tubes) and other products that are made of plastic and metal. Small household appliances (digital cameras, cellular phones, portable audio players and other small household appliances) Not to exceed 20 inches (50cm) in length.	Incombustible Waste Put them into designated collection bags for "Incombustible Waste".	Small Household Appliances Put them into transparent or semi-transparent plastic bags.
	Plastic Containers & Packaging (including Caps and Plastic Labels), Cardboard (collection frequency:every other week) Plastic containers and packaging with the Amark. (Plastic materials with no Amark should be disposed as "Combustible Waste")	Plastic Containers & Packaging Rinse with water before disposing. If dirt cannot be rinsed, dispose of them as "Combustible Waste" Put them into transparent or semi-transparent plastic bags.	Cardboard Flatten cardboards and bundle them with strings.
	Plastic Containers & Packaging (including Caps and Plastic Labels), Glass bottles & Jars (collection frequency: every other week) Plastic containers and packaging with the Amark. (Plastic materials with no Amark should be disposed as "Combustible Waste".)	Plastic Containers & Packaging Rinse with water before disposing. If dirt cannot be rinsed, dispose of them as "Combustible Waste". Put them into transparent or semi-transparent plastic bags.	Glass Bottles & Jars Rinse with water before disposing. If dirt cannot be rinsed, dispose of them as "Incombustible Waste". Place in containers such as baskets or buckets.

If dirt cannot be rinsed, dispose of them as "Combustible Waste". Nozzle of plastic bottles should be disposed as "Plastic Containers	&Packaging". Place in containers such as buckets or baskets. Rigid Plastic Items Put them into transparent or semi-transparent plastic bags.
維紙	Newspapers, Magazines, Milk Cartons & Drink Boxes, Recyclable Papers (collection frequency: every other week) Newspapers, magazines, milk cartons, drink boxes and all kinds of paper for recycl Tissues, paper with stained and laminated papers should be disposed as "Combusti Items that are coated with aluminum should be disposed as "Combustible Waste"		Rinse the inside of milk cartons or drink boxes well, cut them open, and dry them before disposing. Bundle them with strings or put them into paper bags.
DIENG	Cans, Metals (collection frequency: every other week) All cans for food and beverage, not to exceed 18ℓ. Flying pans, folks, knives and other items that are mainly made of metal.	18ℓcans should be crushed as small as possible. Rinse with water before disposing. If dirt cannot be rinsed, dispose of them as "Incombustible Waste".	Place in containers such as baskets or buckets.
	Hazardous waste (products with built-in batteries, batteries, fluorescent tubes, mercury thermometers, disposable lighters, spray cans), old clothes, old textiles Used dry cell batteries, fluorescent tubes, mercury thermometers, disposable lighters, aerosol spray cans. Clothes and blankets for recyclables.	Household Hazardous Waste Put each items except aerosol spray cans into transparent or semi-transpalent plastic bags. Aerosol cans should be placed in containers such as baskets or	buckets. Used Clothing & Fabric Bundle them with strings.

3. Time and Place to Dispose of Waste

Please check the collection schedule of "Calendar for Waste Recycling" and dispose of your waste before 8:00 a.m. on the collection day.

Please dispose of items inside the property alongside the road or at the designated collection site. If you do not follow these rules, your waste will not be collected. Your cooperation would be appreciated.
